



Background

The Security Council has the responsibility of maintaining international peace and security following the principles and purposes of the United Nations Charter. The Security Council is composed of 15 nations, five permanent members (the People's Republic of China, the French Republic, the Russian Federation, the United Kingdom of Great Britain and Northern Ireland, and the United States of America), and ten rotating non-permanent members elected for two-year terms. Each nation has one vote, and all members must comply with the decisions taken. Since its establishment, the Council has authorized peacekeeping missions, put in place international sanctions targeting the finances and access to weapons of rogue regimes as well as extremist groups, deepen international cooperation on matters of international violence and nuclear nonproliferation.

Faculties

To accomplish its mission, the Council has the following functions and powers:

- Guarantee international peace and security.
- Analyze any dispute that may lead to international friction.
- Recommend strategies for adjusting international conflicts.
- Formulate plans for the regulation of armament.
- Apply economic sanctions and other measures avoiding the use of force or military intervention to stop or prevent hostilities.
- Establish subsidiary bodies to achieve the Council's main objective.
- Take military action against an aggressor.

Topic A

Measures to stop the criminal cybernetic groups commanded by Darkside based in the Russian Federation and Eastern Europe regarding the recent attacks made to The United States of America

Introduction

Over the past few years, the Russian Federation and Eastern Europe have served as the headquarters for multiple computer criminals such as Darkside. This is due to the high demand for hackers and computer scientists within the Russian Federation. The modus operandi of these cybernetic groups is known as Ransomware¹(RaaS) and involves both the encryption of information with Salsa20², using an RSA-1024³ public key, as well as the exfiltration of information that is used for the negotiation of payment. Like other similar groups, DarkSide steals information from compromised systems before encrypting it. And if the companies do not want to negotiate the payment of the ransom⁴, DarkSide threatens its victims by filtering it on a site created specifically for this purpose. Within DarkSide, an organizational hierarchical⁵ system is managed in which the leaders are in charge of the development of the hacking mechanisms to later sell them to the public and generate a greater impact. DarkSide has affected numerous organizations in various sectors such as industrial, legal, healthcare, energy, and even insurance. However, according to a publication on the rules of use of DarkSide made on January 27, 2021, on the website of the activist group, affiliated persons cannot attack the funeral services sector, hospitals, residences for the elderly, and companies that distribute the COVID-19 vaccine. The last attack by Darkside and his associates was on the Colonial Pipeline. This pipeline is capable of transporting some three million barrels of fuel a day from Texas to New York over more than 8,800 kilometers.

The closure of said pipeline meant an oil crisis in the region because, as the Colonial Pipeline spokesperson points out, "Tens of millions of Americans trust Colonial: hospitals, emergency medical services, security forces, firefighters, airports, truckers, and the traveling public ". That is why a 75 Bitcoin ransom, the most used cryptocurrency by criminal cybernetic groups, was paid the day after criminals blocked the corporate network of Colonial Pipeline, the company that owns the largest network of oil pipelines in the United States of America. If these attacks continue to spread to more industries and regions of the world, this could culminate in a new era of digital warfare.

The excessive development that criminal organizations have had is mostly due to the educational system, job applications handled, and the lack of existing regulations in nations in Eastern Europe such as the Russian Federation. The educational system gives society the resources, in matters of programming and cybersecurity, and the law does not sanction their misuse. In addition to this, the capacity for adaptation that these criminal organizations have, has meant a great problem, since their adaptability and modus operandi allows cyber-attacks to spread to any industry and region of the world, generating chaos, food crises, and shortage of basic resources such as water. According to data from a global cybersecurity study conducted by Check Point researchers, ransomware attacks have increased 56% globally since early 2021. The ransomware attack on Colonial Pipeline reveals that critical infrastructures are a prime target for cybercriminals.

History of the conflict and recent attacks

The Moonlight Maze attack in 1996, which targeted important governmental agencies from the United States of America, like NASA, NOAA, the Defense Department and the Department of Energy; is considered to be the first important cybernetic strike perpetrated

by Russian government-based hacking groups and the first of its kind, as in the early times of the internet there was no notion about the dangers of online data breaches⁶.

In 2005, the Russian Federation began a big-scale investment in the technological and cybernetic private sectors; around the same time, in 2006 — 2008, a still-active malware called Turla, from a cybernetic organization by the same name, started hosting attacks worldwide, aiming at the exfiltration of prominent organizations, banks, governments and personal information, a connection between the Moonlight Maze and the Turla attacks was later found by a group consisting of world leading cybersecurity provider Kaspersky and members of the Kingdoms's College London. In recent years, Russian hacking groups have been found to intervene in prominent foreign political issues, such as the 2016 Federal Presidential elections of the United States of America; in which several cyberattacks to the Democratic party and influence of vote by targeted ads in Social Media may have altered the process and results of the elections. Furthermore, The DarkSide group was first detected around August 2020 and has already attacked key U.S. hydrocarbon and electrical power infrastructure.

REvil, another Russian-based private ransomware operation similar in behaviour to DarkSide, had been targeting private technology and hardware corporations such as Apple, Quanta Computer, Acer, Kaseya and Invenergy; since May 2020. On July 2, 2021, the REvil operation attacked Kaseya Limited, an American software company, which affected the many systems depending on the company's software all around the globe, such as the Norwegian financial developer Visma, and the Coop supermarket chain in Sweden, which remained unable to operate for days following the attacks shutting down more than 800

stores. Today, intermediary ransomware programs like DarkSide and REvil are the new emerging trend in cyberattacks putting international cybersecurity in danger.

DarkSide's Ransomware model is a threat to the data of multinational corporations who are in charge of providing services to the public, just like the attack on Colonial Pipeline, as well as the personal information of millions of people who place their personal data on banks, online platforms like Google or Facebook, and national and private healthcare systems. The 2018 Facebook-Cambridge Analytica data breach scandal, in which the British consulting firm Cambridge Analytica illegally gathered information from nearly 87 million Facebook profiles, proved personal data to be valuable for the interests of certain political groups. It is very important to ensure the privacy and security of personal and delicate information to avoid potential industrial system accidents or a massive data breach.

Cryptocurrencies and their danger for the international cybersecurity

A cryptocurrency is a digital asset whose purpose is to work as an exchange currency normally stored in encrypted and secured decentralized servers, where all transactions are made public and transparent. In 2009, Bitcoin, the first open-sourced decentralized cryptocurrency was created, making this a new topic. The development in the utilization of virtual monetary forms all throughout the planet has addressed issues for the various states and countries; from its acknowledgment as official currency to the manner by which it will be burdened for acquiring this income. Lately, cryptocurrency has been linked with social media, the defederalization of money and trends, as in the beginning of Bitcoin, people used to trade it in small forums and blogs. More recently, a tweet from the American billionaire, Elon Musk, helped popularize Dogecoin, a bitcoin which has seen a rapid increment on its value since the start of 2021. Furthermore, The Republic of El Salvador was the first country

in the world to accept bitcoin as their official currency. As per their declaration, the motivation behind the law is to manage bitcoin as lawful, delicate, limitless in any exchange and under any title that public or private people or organizations need to do. The law builds up that the trade among bitcoin and the dollar will be set up "openly by the market" and won't be dependent upon capital additions charges like any legitimate delicate. And furthermore, that each financial specialist should acknowledge bitcoin as a type of installment "when it is offered by whoever gains a decent or administration" and that the Executive body will make the important institutional construction for the flow of the digital currency, as per the arrangements In the law.

Virtual monetary forms or digital currencies are not given or controlled by a unified body. On March 9, 2018, in the United Mexican States, the Law to Regulate Financial Technology Institutions (Fintech Law) was distributed in the DOF, which perceives digital forms of money as virtual resources. Presently, number 30 of the purported Fintech Law demonstrates that the portrayal of significant worth enlisted electronically and utilized among people in general as a method for installment for a wide range of lawful demonstrations and whose move must be helped out through electronic media. All digital money moves are made on the web and have attributes that leave presumably regarding why the programmers of the enormous 'ransomware' assault have decided to gather their ransom in bitcoins: in activities with these monetary standards there are no intermediaries, they are completed in P2P organizations (safer than the typical channels) and the encryption of the exchanges, which are public, is unpredictable to such an extent that it is hard to follow between the individuals who are occurring the trade.

Measures taken by the international community to solve the issue

The International Telecommunications Union or the ITU is a United Nations agency considered as the global forum which parties work towards a range of issues affecting the ICT Industry⁷, creating the Global Cybersecurity Agenda⁸. This Agenda identifies 5 different strategic pillars that are the legal, technical, organizational, capacity-building and cooperation. Each one of these pillars has a specific work. The *legal* pillar focuses on harmonizing laws and regulations related to cybersecurity. The *technical* is in charge of covering all the high-tech issues that may seem as cybersecurity threats. The *organization* focuses on structuring the policies and are responsible for the agencies in charge of the coordination of the cybersecurity policy. The *capacity-building* is in charge of spreading awareness and promoting cybersecurity. And finally, the *cooperation* focuses on inter-agency and public-private partnerships.

Another variable solution is the International Law of Cyber Security, which has been working to offer and guarantee a safe internet environment, taking care of the financial transactions that take place on the web every day, the power of this law also has the objective to extend more rules and regulations for the network safety. Topic B

Mechanisms to address the growing crisis regarding naval disputes located in the South People's Republic of China Sea region

Introduction

Since the 1970s the naval territories of the South People's Republic of China Sea have been claimed and disputed by countries around the area, such as the People's Republic of China, Brunei Darussalam, Malaysia, the Republic of the Philippines, and the Socialist Republic of Vietnam. In recent years, the unarmed conflict has been internationalized, as claims by the People's Republic of China, a key player in the global economic and diplomatic stage, have been opposed by members of the Association of Southeast Asian Nations (or ASEAN⁹), supported by the United States of America (US) who, in association with the Republic of the Philippines, has conducted a series of military exercises in the region; as recently as April 12, 2012 both governments announced a period of two weeks in which their militaries would conduct drills and demonstrations near the disputed Whitsun Reef (main atoll ¹⁰of the Spratly Islands, South People's Republic of China Sea) and Japan, who has continually sent armed naval patrols to the area and sold equipment and military ships to the Republic of the Philippines and the Socialist Republic of Vietnam with the justification of naval defense and security over said countries. In June 2017, Japan and the Socialist Republic of Vietnam signed an agreement for ¥38 billion (Japanese Yen) (\$343,704,300.00 US dollars) in military aid, vessels¹¹, and expansion in patrolling capability. The direct armed conflict between dominant regional actors like the People's Republic of China and Japan,

and the intervention of the United States of America is an issue that threatens the international well-being and efforts for peace.

While confrontation on the Spratly islands, the main archipelago of the region, has been almost nonexistent, there are several triggers for conflict that could, at any time, unchain a regional crisis or even affect the interests of nations worldwide, just as the regional geopolitical tensions, the claiming of jurisdiction and law making over the disputed zones, and exploration and exploitation of the resources by any of the claimants. An armed conflict could interfere in the development of the Asian economy and global manufacturing, as the People's Republic of China alone contributes to about 18.7 % of the total manufacturing output (2019). The key markets of Southeast Asia: the ASEAN international community and the People's Republic of China, are worth \$3.356 trillion and \$16.44 trillion each (USD nominal; 2021), as much as \$3.37 trillion worth was traded through the region, nearly as 40 percent of the world's liquefied natural gas passed through the South People's Republic of China Sea in 2017, and at least 87 % of the European Union's total imports being produced in ASEAN nations, making this region prominent for the global economy.

History of the conflict and the importance of these maritime territories.

People's Republic of China provides details regarding its encouragement in the contested oceans of Asia Pacific. In mid-April 2020, the Chinese media distributed a "major move" taken by the public authority: the production of two new regions as a component of the city of Sansha, on the southern island of Hainan. This isn't just a straightforward managerial¹² activity since these new regions are situated in the conflictive and vital waters

of the South People's Republic of China Sea: Beijing. The new land that People's Republic of China will oversee are in the Spratly Islands (which People's Republic of China calls Nansha), the Macclesfield Bank (called Zhongsha by the Chinese), the Paracel archipelago (in Chinese, Xisha) and environmental factors, which again brought rankles up in the Socialist Republic of Vietnam or the Republic of the Philippines, who reacted with brutal fights. Since the coming to force of President Xi Jinping in 2012, the People's Republic of China has been devoted to underlining the significance of its power and underscoring the sea privileges of that country.

The Chinese government has guaranteed practically the whole South People's Republic of China Sea as its own, and under the order of Xi Jinping has implicitly declared the region from urban communities to airstrips or vacationers and military offices. Because of the past activities performed by the Chinese government, the global-local area, explicitly the countries of the Republic of the Philippines, the Socialist Republic of Vietnam, Taiwan, Malaysia, and Brunei Darussalam, additionally guarantee as to their own part of the region and the argument about various islands, reefs and their abutting waters that have been unsettled for a long time. The US, under the contention of guarding "opportunity of route" nearby, has expanded its essence adjacently. 30 % of worldwide exchange circles in the South People's Republic of China Sea and is accepted to be home to valuable oil and gas stores. During the most recent couple of months the world has been engaged with a worldwide pandemic because of COVID-19. While Southeast Asian countries in the South People's Republic of China Sea have ended up in emergency dealing with the pandemic, the People's Republic of China has dispatched a mission of chance and development across the region.

The South People's Republic China Sea, in some cases additionally called the South People's Republic of China Sea, is a critical route between the Indian Ocean and the Pacific Ocean. About 33 % of all world transportation goes through the region. Furthermore, the shipping lanes utilization moves trillions of dollars a year. Notwithstanding the People's Republic of China, the Socialist Republic of Vietnam, the Republic of the Philippines, Malaysia, Brunei Darussalam, and Taiwan guarantee sway¹³ over various islands. Yet, the People's Republic of China doesn't view it as such and claims about 90 % of the waters of the South People's Republic of China Sea. Additionally, the United States, demands its entitlement to unreservedly explore worldwide waters in regions that Beijing considers its own. The People's Republic of China's contention depends on a verifiable case. The Beijing government says its privileges to those waters date back a few centuries, to when the Paracel and Spratly islands, brought in the People's Republic of China: Xisha and Nansha, individually, were viewed as a fundamental piece of its domain. Also, in 1947 the People's Republic of China distributed a guide that became known as the "nine-point line", which delimits its regional aspirations nearby, and which completely incorporates these two huge gatherings of islands. In 2016 an arbitral court of the United Nations Convention on the Law of the Sea excused the Chinese chronicled guarantee inside that line and ordered a significant number of the islands as rocks. However, People's Republic of

China disregarded that decision and as of late has not exclusively been fortifying its tactical presence in the South People's Republic of China Sea, yet has additionally constructed various fake islands, which is against worldwide law. This kind of development has strengthened since the rise to power of Xi Jinping in 2012. In any case, it should be explained that albeit¹⁴ the Chinese are by a long shot the ones who have assembled the most, they are not by any means the only ones. The Republic of the Philippines and the Socialist Republic of Vietnam have additionally been expanding on questioned islands.

Although the United States isn't straightforwardly associated with this regional question, lately, it has been sending more warships to said region. The US government says it is to safeguard their opportunity of route in global waters. As far as concerns, the People's Republic of China has expanded the number of military activities nearby, which has created apprehension. Moreover, the Biden government has effectively reported its obligation to help its partners in the region, cooperating with Japan, Australia, and India to check the developing Chinese presence. Both the United States and the People's Republic of China blame each other for having mobilized the South People's Republic of China Sea. In the meantime, countries with claims are left in upset waters, attempting to protect their public advantages amid the two economic and military great power nations.

Economic and Ecological Impact

The geographical location of the South China Sea, as well as its comfortable temperature for marine life, makes it rich in natural resources and biodiversity, being home for approximately 3,365 species of fish. The South China Sea is presumed to have the most congested international sea lanes and the busiest fishing zone in the world, with over 50% of

the world's catching vessels estimated to wield in the region. Nonetheless, territorial disputes and overfishing have been the main issues threatening the well-being of the fishing industry. In 2015, the region alone produced over 12% of the global fish catch, employing around 3.7 million people in the fishing sector and producing over 16.6 million of tons in catch every year. However, the stock value on fishing in the South China Sea has fallen by 66 to 75 percent in the last decades, and according to a study from 2015 by U. R. Sumaila and W. Cheung from the University of British Columbia, it is predicted that the value in key fish-stocks will fall 50 % by 2045.

In recent years, the Chinese government has instructed engineers for the piling of sand over important reefs near the Spratly islands with the goal of building military bases over the artificial islands derived from the People's Republic of China's campaign of aggressive dominance over the South China Sea, which has now put at risk the region's natural heritage by destroying various banks of sand and offshore reefs. Regardless, the People's Republic of China's main interest in the region comes from ensuring its access to carbon-based energy sources, needed to power the livelihoods of over 1.398 million people (2019). It is estimated for the South China Sea to hold around 14 billion barrels of natural gas and anywhere between 16 to 33 billion barrels of oil in undersea reserves, accounting for an estimated \$2.5 trillion in hydrocarbon reserves.

Boat sinking and international tension

In April 2020, a Vietnamese fishing boat sank close to the contested Parcel Islands, following an episode with a Chinese Coast Guard watch boat. The Socialist Republic of Vietnamese government blamed the Chinese powers for sinking the boat, while the Chinese government guaranteed that it had slammed into the watch boat and was completing

"criminal operations". That incited Washington to encourage the subsequent force to be reckoned with to zero in on aiding the pandemic and quit exploiting the interruption or weakness of different states to grow their illicit cases in the South People's Republic of China Sea. The Chinese government completely denied this allegation, asking not to blend the two situations and underlining the steady US military movement in this essential piece of the world. However, the episode that stresses specialists the most isn't the Socialist Republic of Vietnamese fishing boat.

As reported, the United States and Australia were sending warships to the region to 'show presence'. From the American attack transport USS America, sent in the South People's Republic of China Sea. Gotten some information about late activities by People's Republic of China in the essential region, the back chief naval officer guaranteed that all collaborations "with the People's Liberation Army Navy in the South People's Republic of China Sea keep on occurring as per worldwide norms." However, the Chinese side unequivocally censures the pretended by Washington and which, as he would see it, puts harmony and strength in danger. The US, regardless of reporting its right to public sway in all spaces under the Trump organization, has done all that could be within reach to abuse that of the People's Republic of China, particularly in the South People's Republic of China Sea. The US Navy has regularly worked in global waters of the South People's Republic of China Sea for over 75 years, and they contend to add to the strength and security of the area likewise emphasizing their obligation to an open and free Indo-Pacific, in which every nation can work.

Negotiations carried out by the international community

The circumstance happens amidst moderate dealings, which might be vital to fixing a "Set of principles" in the locale, connected at the hip with the Association of Southeast Asian Nations (ASEAN) and People's Republic of China. The Association of Southeast Asian Nations desires to assist dealings on a set of accepted rules with People's Republic of China for the South People's Republic of China Sea. The People's Republic of China and the 10-part ASEAN coalition received an arranging system on the code for the contested and swarmed stream, to a great extent constrained by the People's Republic of China yet in addition asserted by some ASEAN states. As Singapore Defense Minister, Ng Eng Hen told journalists after a gathering of ASEAN protection bosses, "We trust it will pass, however it is an extremely complex issue," (Ng Eng Hen, 2021). "It's an extremely old question. Anticipating (the code) in a year is ridiculous,"(Ng Eng Hen, 2021) Notwithstanding, the absence of laying out as an underlying target the need to make the code lawfully restricting raised questions about the adequacy of the agreement. "We are seeing two patterns simultaneously: from one perspective, both military powers expanding their quality and tasks in the district, while accusing one another (...)
